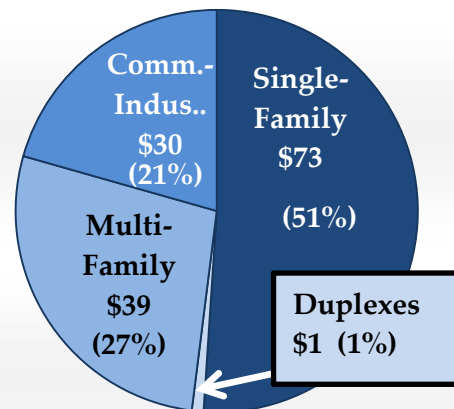

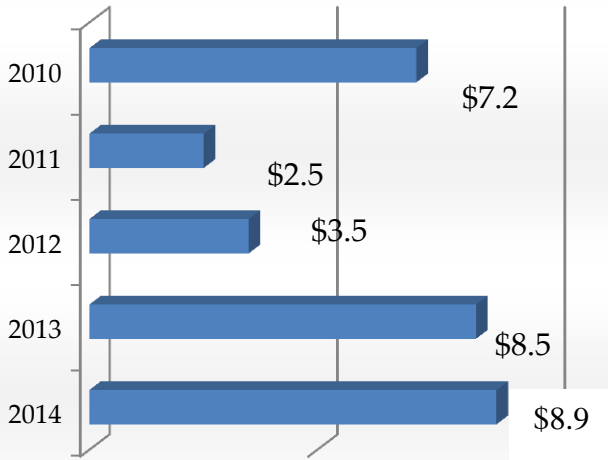

### 2005-2014 Value of New Const. Activity (In millions of \$)



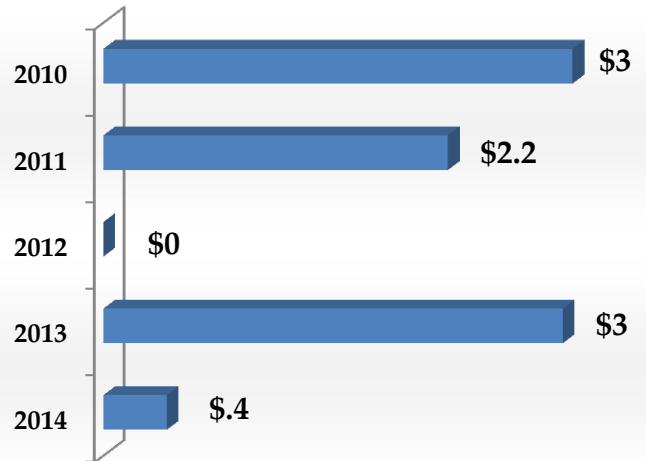

(In millions of \$)



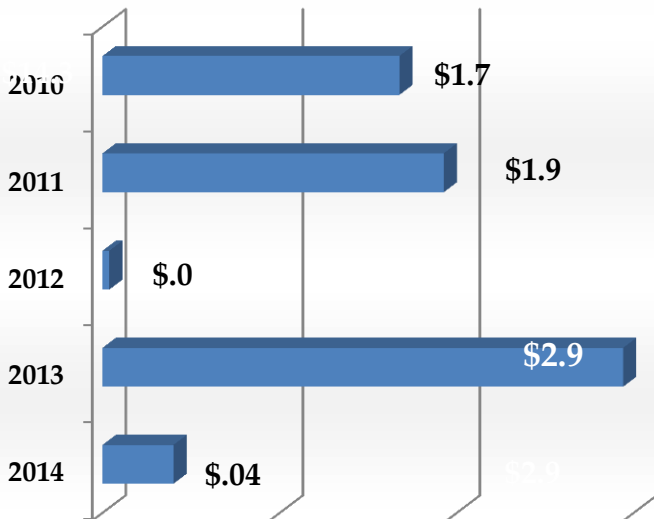
